EXECUTIVE ORDER No. 06
Series of 2017

PROVIDING FOR THE REORGANIZATION OF THE MUNICIPAL ANTI- DRUG ABUSE COUNCIL (MADAC), ITS COMPOSITION AND FUNCTIONS IN THE MUNICIPALITY OF CULION.

WHEREAS, the 1991 Local Government Code constitution mandates that the government shall promote the quality life of the people;

WHEREAS, Section 16 of the Local Government Code or the General Welfare Clause of the Local Government Code of 1991 also provides that LGU's shall pursue undertaking to improve public morals and maintain peace and order;

WHEREAS, the increasing use of illegal drugs has significantly constituted to the incidence of heinous crime and the problems related thereto should be properly addressed to help ensure community peace and harmony;

WHEREAS, DILG MC No. 96-227 dated December 2, 1996 provides the necessary guidelines for the organization of the said council;

NOW, THEREFORE, I, MA. VIRGINIA N. DE VERA, Municipal Mayor of Culion, Palawan, by the virtue of the powers vested in me by law, do hereby order the reorganization of the Municipal Anti-Drug Abuse Council this municipality.

Section 1. COMPOSITION. The Municipal Anti- Drug Abuse Council (MADAC) shall be composed of the following;

Section 2. FUNCTIONS. The council shall perform the following duties and function;



1. Serve as a focal point through which various organization and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;
2. Provide for an effective mechanism for the coordination of existing services and programs and those which might be developed in the immediate future;

3. Provide for a mechanism to obtain funds, volunteers, facilities, and technical expertise, and
4. Perform such other duties and functions.


Section 3. MEETINGS. The Council shall meet as often as may be necessary
