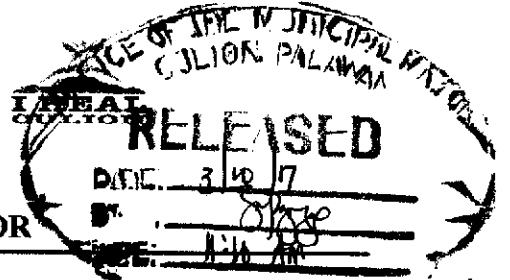

FORMULATING OF LOCAL CLIMATE CHANGE ACTION PLAN (LCCAP) OF CULION, PALAWAN

WHEREAS, the LGU, as a political unit, is mandated to exercise its inherent power, such as the polices power, and share with the national government the responsibility in the management and maintenance of ecological balance in their respective territorial jurisdictions, as provided for in R.A 7160 Section 2a, 15, 3i,

WHEREAS, being a corporate body the LGU is mandated to promote the general welfare of its inhabitants within its territorial jurisdiction;

WHEREAS, Section 14 of R.A 9729 (Climate Change Act of 2009) as amended by R.A 10174, provides that the LGUs shall be the frontline agencies in the formulation, planning and implementation of climate change action plans in their respective areas, consistent with the provisions of the Local Government Code (LGC) and the National Framework Strategy on Climate Change (NCCAP) and the National Climate Change Action Plan (NCCAP);

NOW, THEREFORE, pursuant to all the above, I, **MA. VIRGINIA N. DE VERA**, Municipal Mayor of Culion, Palawan, by virtue of the powers vested upon me by the law, do hereby constitute/formulate the Local Climate Change Action Plan Core Team who will lead, oversee, and ensure that an LCCAP will be drafted, eventually approved, implemented, regularly monitored and updated when necessary.

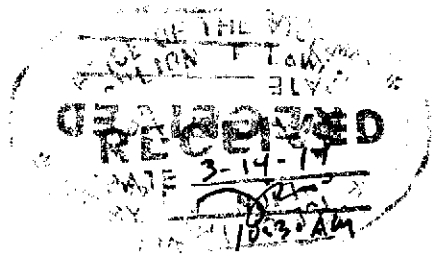

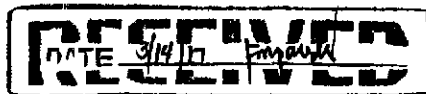

FUNCTIONS, the LCCAP Core Team shall exercise the functions as enumerated and contained in Memorandum Circular No. 2014-135 of then DILG Secretary Mar Roxas, dated October 21, 2014, addressed to Provincial Governors, City and Municipal Mayors, Punong Barangays, DILG Regional Director and all others concerned, copy attached.


SECTION 3. MEETINGS AND QUORUM, the Core Team shall meet once at least every six (6) months or as often as may be necessary. A majority of the members present shall constitute a quorum.

SECTION 4. SECRETARIAT, a secretariat for the LCCAP Core Team is hereby constituted to be headed by Mr. Teodoro S. Sablada. It shall be responsible in providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharge of functions of the Core Team.

SECTION 5. FUNDING, the necessary funding for functioning and operation of the Core Team shall be provided in every annual budget of the municipality and/ or any additional fund from any partner/s if applicable.

SECTION 6. EFFECTIVITY, this Order shall takes effect immediately.
