



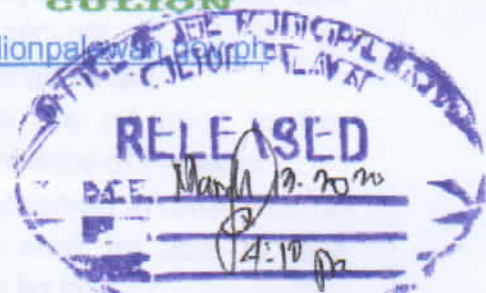

EXECUTIVE ORDER NO. 16-A
Series of 2020

EXECUTIVE ORDER LAYING DOWN THE PROCEDURE IN CASE A COMMUNITY QUARANTINE NEED TO BE IMPLEMENTED IN THE MUNICIPALITY OF CULION

WHEREAS, considering the global pandemic caused by NCOVID-19 precautionary measures are needed to arrest the spread of such.

WHEREAS, the health and safety of all residents of Culion is the primary concern of the Local Government Unit.

WHEREAS, in this trying time we all have a social responsibility to observe and comply with.

WHEREAS, under the Police Power of the Local Government shall promote and ensure and support, among other things, promote health and safety.

WHEREAS, as per advised by the Inter Agency Task Force one of the effective methods to counter the spread of the dreaded virus is to practice social distancing.

WHEREAS, the Local Government Code Provides that the Municipal Mayor may issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances.

WHEREAS, pursuant to the local trend of local transmission of the dreaded virus, precautionary measures are being implemented.

WHEREAS, the Local Government Code Provides that the Municipal Mayor may issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances.


NOW, THEREFORE, I, MA. VIRGINIA N. DE VERA, Municipal Mayor of the Municipality of Culion, Province of Palawan by virtue of the Power vested in me by law do hereby issue this Executive Order.

1. In case the need arises to impose community quarantine when there be a confirmed case in any sitio or barangay the following shall be observed and be implemented;
 - a. The RHU and the MDRRMO shall take the lead and implement the necessary measure and shall utilize the barangay as a force multiplier in order to ensure that the proper medical routine would be utilized in order to achieve the desired goal of a quarantine.

- b. Strict implementation of the municipal curfew shall be strictly be observed.
 - c. All residents shall be required to stay at their homes and minimize any public interactions to the minimal.
 - d. Proper social distancing shall always be observed.
 - e. Mandatory quarantine for those who are returning to this Municipality coming from outside the province of Palawan.
2. A price monitoring and price freeze shall be observed in order that no unscrupulous traders, suppliers and retailer shall be able to take advantage of the state of calamity the said sitio be in.
 3. No person shall be allowed to leave the vicinity of the said sitio or barangay except for medical and other emergencies.
 4. The PNP-Culion may be called upon to strictly guard the Borders of the said area to ensure that no person shall try to leave the said area.
 5. No person shall be allowed to enter the said sitio or barangay as well. Isolation shall be an important measure to be able to ensure that the dreaded disease could be contained.
 6. The MDRRMO shall be the one to be in charge in delivering the supplies for the said sitio, the said office shall be in charge in creating the necessary guidelines to be observed on how to achieve such.
 7. The BFP-Culion is hereby called upon to cooperate with the RHU and MDRMMO in order to utilize their any capable fire trucks and undergo public sanitation of the whole quarantined area, as frequent as needed as may be instructed by the RHU thru their issued guidelines.

This order shall take effect immediately upon approval thereof and shall remain in full force and effect unless sooner revoked or amended by the Local Chief Executive.
