

EXECUTIVE ORDER NO. 13

EXECUTIVE ORDER ORDERING A PRECAUTIONARY ACTIONS IN THE LIGHT OF THE COVID-19 SITUATION IN THE MUNICIPALITY OF CULION PROVINCE OF PALAWAN

WHEREAS, as precautionary measure to protect the inhabitants of the Municipality of Culion, preventive measures are hereby being placed.

WHEREAS, health and safety of the People are in peril due to the pandemic virus, precautionary measures are to be implemented in the whole municipality.

WHEREAS, as directed by the Inter Agency Task Force social distancing shall be a key in prevention of the widespread transmission of the virus.

WHEREAS, the Local Government Code Provides that the Municipal Mayor may Issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances.

NOW, THEREFORE, I, MA. VIRGINIA N. DE VERA, Municipal Mayor of the Municipality of Culion, Province of Palawan by virtue of the Power vested in me by law do hereby issue this Executive Order.

- A temporary total ban shall be implemented on all tourism activities within the Municipal Territorial jurisdiction of the Municipality of Culion, the duration shall be for 30 days from the issuance of this decree or until such time that the Inter Agency Task Force shall lower the alert level being implemented.
- 2. All ingress and egress from the Municipality shall be only thru the Port of Culion as to be able to monitor all those who would enter the Municipality. The Municipal Police together with the Philippine Coast Guard are hereby called upon to regularly patrol and take necessary plan of action in the whole municipality in order to discourage all those who may want to enter the municipality illegally.
- All Punong Barangays are hereby strictly mandated to monitor all
 possible ingress of tourist boats that may enter their territorial
 jurisdiction, they are hereby mandated to coordinate such immediately
 to the office of the Mayor for proper coordination to the Municipal Police
 and the Philippine Coast Guard.
- The MDRRMO is hereby ordered to strictly monitor all incoming people thru the municipal port, wherein they shall ensure that the name, contact details and permanent address should be divulged furthermore they

shall be required to divulge the purpose of their visit to Culion and where would be staying during their duration. All information are required to be divulged under the penalty of law in case they falsify any material information, it shall be required from them to divulge information if they travelled from Manila or other foreign Country from the last 15 days. Such information shall be used to monitor all incoming transients in the municipality and shall be used for contact retracing in case there be an instance of COVID-19 in our Municipality.

- Furthermore, all legitimate and bonafide returning residents of the Municipality of Culion returning to Culion from Manila and other area outside the Calamines are hereby required to undergo 10 days selfquarantine.
- The RHU and the MDRMMO are hereby mandated to create an implement their policy for such.
- The RHU is called upon to closely coordinate with the MDRMMO, in order to prepare our people and Municipality.

This order shall take effect immediately upon approval thereof and shall remain in full force and effect unless sooner revoked or amended by the Local Chief Executive.
