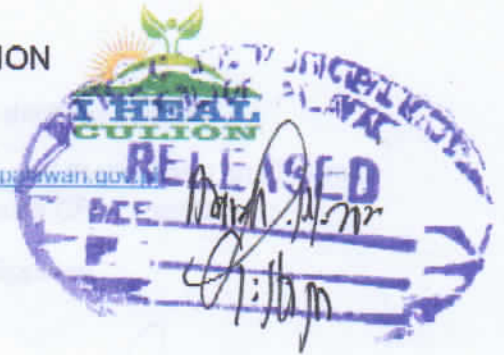

EXECUTIVE ORDER NO. 14
Series of 2020

AN EXECUTIVE ORDER CALLING UPON ALL BARANGAY OFFICIALS WITHIN THE MUNICIPALITY OF CULION TO STRICTLY ENFORCE THE CURFEW ORDINANCE WITHIN THEIR RESPECTIVE TERRITORIAL JURISDICTION AS A FORM OF PRECAUTIONARY MEASURE AGAINST THE DREADED NCOVID-19 AND AS A FORM OF SOCIAL DISTANCING AS ONE OF THE MEASURES TO BE OBSERVED IN ORDER TO CURB THE SPREAD OF THE VIRUS.

WHEREAS, in this trying time we all have a social responsibility to observe and comply with.

WHEREAS, under the Police Power of the Local Government shall promote and ensure and support, among other things, promote health and safety.

WHEREAS, as per advised by the Inter Agency Task Force one of the effective methods to counter the spread of the dreaded virus is to practice social distancing.

WHEREAS, the Local Government Code Provides that the Municipal Mayor may Issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances.

NOW, THEREFORE, I, MA. VIRGINIA N. DE VERA, Municipal Mayor of the Municipality of Culion, Province of Palawan by virtue of the Power vested in me by law do hereby issue this Executive Order.


1. A precautionary curfew at 8pm shall be imposed on the whole Municipality in response to the pandemic virus that is affecting not only the whole country but the whole world as well. The barangay is requested to ask them to return to their respective homes and avoid unnecessary exposure that may lead to compromising their health and their love ones.
2. In case of extreme urgency, the barangay may call upon the Municipal Police to assist them in performance of their duties.
3. No penal violation shall be imposed upon those caught from 8pm to 9:59pm, however those caught from 10pm onwards shall face penal sanction as per mandated by our municipal ordinance regarding curfew.
4. The Barangay officials shall in their respective territorial Jurisdiction shall take the lead in enforcing this social distancing measure, wherein all those seen outside in the streets shall be asked to return their respective homes, minors who would be caught shall be escorted to their respective homes and shall be delivered to their parents or guardians.
5. All barangay officials are hereby mandated to coordinate to all business establishment owners in their respective territorial jurisdiction to request that their cooperation in this trying time is indispensable, thus it shall be requested that they close their establishments at 8 pm in order to be able to avoid people loitering.

6. The barangay is hereby mandated to strictly enforce the no drinking in public.

This executive order shall take effect immediately upon approval thereof and shall remain in full force and effect unless sooner revoked or amended by the Local Chief Executive.
