EXECUTIVE ORDER NO. 15
Series of 2020

EXECUTIVE ORDER MANDATING MANDATORY QUARANTINE FOR ALL RESIDENTS AND TRANSIENTS ENTERING THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF CULION, PROVINCE OF PALAWAN WHO HAD TRAVEL HISTORY OUTSIDE THE PROVINCE OF PALAWAN TO BE SUBJECTED TO A MANDATORY 14 DAYS QUARANTINE

WHEREAS, considering the global pandemic caused by NCOVID-19 precautionary measures are needed to arrest the spread of such.

WHEREAS, the health and safety of all residents of Culion is the primary concern of the Local Government Unit.

WHEREAS, pursuant to the local trend of local transmission of the dreaded virus, precautionary measures are being implemented.


WHEREAS, the Local Government Code Provides that the Municipal Mayor may Issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances.

NOW, THEREFORE, I, MA. VIRGINIA N. DE VERA, Municipal Mayor of the Municipality of Culion, Province of Palawan by virtue of the Power vested in me by law do hereby issue this Executive Order.

1. The MDRRMO together with the RHU are hereby called upon to draft their joint implementing rules and regulation to address this pressing matter. They are hereby likewise mandated to set up the necessary quarantine area that would be utilized as the municipal quarantine area.
2. The RHU is hereby tasked to take the lead in forming the necessary questionnaire that would be given to all inbound people in order to be able to assess the risk.
3. To ensure truthfulness from such response, it should be ensured that their personal details shall be verified by requiring at least one valid identification card.
4. In case there be no valid identification present, they shall not be denied entry but rather they need to execute an affidavit under oath.
5. All data gathered shall be solely be used as extreme measure in case there be a need to conduct contact tracing in case there be an outbreak in our Municipality.

This executive order shall take effect immediately upon approval thereof and shall remain in full force and effect unless sooner revoked or amended by the Local Chief Executive.
