EXECUTIVE ORDER NO. 112

CREATING THE ARAMPANG-AMPANG TEAM AND TECHNICAL WORKING GROUP TO ATTEND TO AND MANAGE THE ANNUAL TIRIMES-TIMES FESTIVAL.

WHEREAS, on March 12, 2009, Municipal Ordinance No. 2009-15 was ordained through the 5th Sangguniang Bayan of Culion, which was amended by the 7th Sangguniang Bayan and approved on the 12th of October 2015;

WHEREAS, said amendment has declared that Section 3 of Municipal Ordinance No. 2009-015 is hereby amended to read now as follows, Section 3. Celebration of the "Tirimes-Times" Festival. The Municipality shall celebrate a month-long festivities to be known as the "Tirimes-Times" Festival in the month of May of every year beginning 2016. In the year 2016, the highlight week and day of the festival shall be the last week of May and May 27, respectively, in due recognition and celebration of the 111th founding anniversary of Culion as a former leper colony;

WHEREAS, said festival, being a month-long celebration requires the attention of an organized management group to ensure success of the celebration;

WHEREAS, said festival will be an opportune time to showcase the natural beauty of Culion and reminisce on the rare and significant history in the field of medicine - Hansen's disease;

NOW THEREFORE, I, MA. VIRGINIA N. DE VERA, Municipal Mayor of Culion, Palawan, by the virtue of the powers vested in me by the law do hereby order:

Section 1. Creation. There is hereby created in the Municipality the Arampang-Ampang Team and Technical Working Group (TWG) for the "Tirimes-Times" Festival;

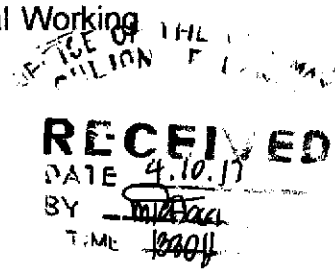

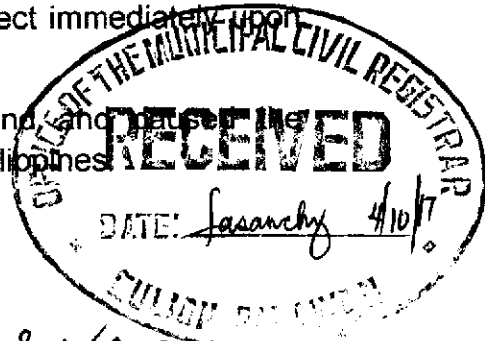
