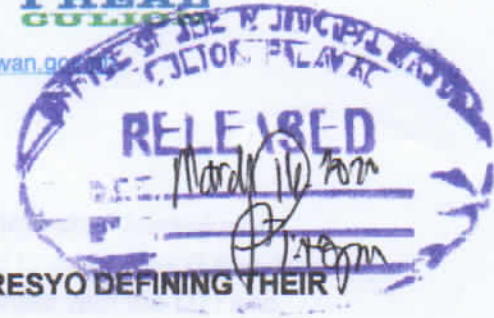

**EXECUTIVE ORDER NO. 16**  
 Series of 2020

**AN EXECUTIVE ORDER CREATING THE TASK FORCE BANTAY PRESYO DEFINING THEIR DUTIES AND RESPONSIBILITIES.**

**WHEREAS**, the local government code provides that the Local Chief Executive shall carry out such emergency measures as may be necessary during and in the aftermath of man-made and natural disasters and calamities.

**WHEREAS**, the Local Government Code provides that local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

**WHEREAS**, in this trying time, the Local Government would like to establish order and stability to the community and assure that there would be no unscrupulous traders, retailers and any entrepreneur to take advantage of the situation and jack up the prices of the basic and prime commodities needed in case the Municipality be penetrated by the dreaded virus.

**WHEREAS**, the local government aims to ensure that basic commodities are sufficient for the whole municipality.

**WHEREAS**, the Local Government Code Provides that the Municipal Mayor may Issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances.

**NOW, THEREFORE, I, MA. VIRGINIA N. DE VERA**, Mayor of the Municipality of Culion, Province of Palawan by virtue of the Power vested in me by law do hereby issue this Executive Order;

1. The Municipal Bantay Presyo sa Culion Task Force is hereby created, the composition of which shall be the following;



2. Upon approval and issuance of this executive order, the task force shall immediately convene to discuss the actions and program to be implemented to ensure food stability and price check on all commodities. The task force shall coordinate with the DTI and other National Agencies Counterpart.

This executive order shall take effect immediately upon approval thereof and shall remain in full force and effect unless sooner revoked or amended by the Local Chief Executive.
