**MOBILIZING THE RESPECTIVE OFFICES UNDER THE EXECUTIVE DEPARTMENT TO FORM PART OF TECHNICAL WORKING GROUP FOR THE LAUNCHING OF PROGRAMANG MALASAKIT SA NAKAKATANDA PROGRAM WHICH AIMS TO ASSIST THE SENIOR CITIZENS OF THE MUNICIPALITY OF CULION REGARDING THEIR SOCIAL PENSION AND OTHER NEEDS**

**WHEREAS**, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

**WHEREAS**, local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities;

**WHEREAS**, social welfare services which include programs and projects on child and youth welfare, family and community welfare, women's welfare, welfare of the elderly;

**WHEREAS**, the municipality of Culion consists of several barangays some of which are in isolated island that would require travel by sea;

**WHEREAS**, the Municipal Government aims to give convenience to the elderly as to personally bring the necessary service personally to them at the convenience of their homes.

**NOW, THEREFORE, I, MA. VIRGINIA N. DE VERA**, Mayor of the Municipality of Culion, Province of Palawan by virtue of the Power vested in me by law do hereby issue this Executive Order;


1. The following Heads of these department shall form part of the technical working group which would assist the Office of the Mayor in implementing the programs which aims to benefit all senior citizens of the Municipality of Culion;
  - a. Municipal Social Welfare Department
  - b. Office of the Senior Citizen Affairs
  - c. Municipal Treasurer
  - d. Municipal Health Officer
  - e. Municipal Civil Registrar
  - f. I HEAL Manager on Livelihood
  - g. The Municipal Administrator
2. Upon convening of the Technical working group shall prepare the plan of action on the implementation of the following programs;
  - a. Mobile Registration of all Senior Citizen in the Municipality of Culion

- b. Social Pension Allocation and Door to Door Distribution
  - c. Kwentuhan sa Barangay program, aims to bring the local government closer to the people wherein they be able to ventilate their issues and concerns.
3. Funding would be sourced from the individual allocated budget of concerned departments.

Any previous order issued relative hereto shall be superseded by this order.

This Order takes effect immediately.
