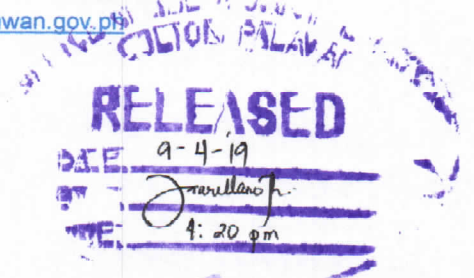

EXECUTIVE ORDER NO. 20  
Series of 2019

**AN EXECUTIVE ORDER MANDATING ALL PUNONG BARANGAYS OF THE MUNICIPALITY OF CULION TO COORDINATE WITH THE OFFICE OF THE MAYOR REGARDING ANY PROJECTS TO BE IMPLEMENTED WITHIN THEIR TERRITORIAL JURISDICTION INITIATED BY ANY NATIONAL GOVERNMENT AGENCIES (NGAs) AND THEIR COUNTERPARTS**

**WHEREAS**, Provincial Resolution No. 14389 s 2019 urges that the projects of the national government be presented first to the Local Chief Executive before implementation for proper information and coordination;

**WHEREAS**, under the Local Government Code the Municipal Mayor as the Chief Executive is mandated to exercise powers and perform duties and functions necessary to promote the general welfare of the locality and its inhabitant;

**WHEREAS**, the Municipal Mayor exercises general supervision and control over all programs and projects, services and activities in their respective jurisdiction;

**WHEREAS**, to optimize the efficiency of government service to the people, to avoid redundancy and achieve maximum proficiency of all government resources;

**THEREFORE, I, MA. VIRGINIA N. DE VERA**, Municipal Mayor of the Municipality of Culion, Province of Palawan by virtue of the power vested in me by law do hereby issue this Executive Order;


1. All Punong Barangays are hereby mandated to coordinate with the Office of the Municipal Administrator regarding any projects to be implemented in their respective jurisdiction spearheaded by any National Government Agency (NGA) or their counterpart prior to the issuance of any barangay permit or clearance.
2. Update the Office of the Municipal Administrator of any ongoing project or program currently being implemented in his/her barangay which is spearheaded by any National Government Agency (NGA) or their counterparts.
3. In case a project would be implemented in their respective area of jurisdiction, notice should be sent to the Office of the Municipal Administrator at least three (3) working days for proper coordination

with proper agency concerned and wait for proper coordination from the Municipal Administrator Office.

4. Failure to comply with this executive order would be a ground for administrative sanction.

This Executive Order shall take effect immediately.
