AN EXECUTIVE ORDER REITERATING TO THE PUBLIC TO OBSERVE PROPER SOCIAL DISTANCING AND ORDERING THE MANDATORY USE OF FACE MASK WHEN OUTSIDE ONE'S RESIDENCE AND WHEN TRANSACTING IN PUBLIC OFFICES AND OTHER PUBLIC PLACES IN THIS MUNICIPALITY.

WHEREAS, as a preventive measure in order to curve the spread of the deadly virus currently devastating the country.

WHEREAS, part of our social responsibility in ensuring that the virus would not be spread, ensuring vigilance on our part by observing proper protocols and wearing of masks.


WHEREAS, paragraph J of the IATF Resolution No. 18, Series of 2020 mandates all LGU's to issue an Executive Order or Ordinance to cause the mandatory wearing of facemasks in their respective localities.

WHEREAS, under the Police Power of the Local Government shall promote and ensure and support, among other things, promote health and safety.

WHEREAS, the Local Government Code Provides that the Municipal Mayor may Issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances.

I MA. VIRGINIA N. DE VERA, Mayor of the Municipality of Culion, Province of Palawan by virtue of the Power vested in me by law do hereby issue this Executive Order.

1. The Public is hereby advised to strictly observe the social distancing measure being implemented and mandated to wear face masks when going out of their residences as a safety precaution and measure in order to protect themselves and the community from transmitting the virus.
2. Allowable masks are the following, n95 mask, surgical mask, ear loop mask, cloth made mask or any ingenious do it yourself reusable mask, face shields, handkerchiefs or such other protective equipment that can effectively lessen the transmission of the virus.
3. All Punong Barangays are hereby called upon to strictly enforce this directive to their respective area of jurisdiction, ensure that in every check point it would strictly be observed and enforced.
4. Violators caught would be asked to return home and secure their respective face masks.
5. In case the violator would cause ruckus and disobey the lawful order, the Municipal Police is hereby called upon to assist the barangay front liners, they shall be endorsed to the Municipal Police for appropriate charges against them.
