EXECUTIVE ORDER NO. 25 Series of 2017

CONSTITUTION OF THE SEAL OF GOOD LOCAL GOVERNANCE TEAM AND ITS TECHNICAL WORKING GROUP OF LOCAL GOVERNMENT OF CULION

WHEREAS, DILG Memorandum Circular No. 39-2014 dated March 24, 2014 provides guidelines on the eligibility of Local Government Units for the Seal of Good Local Governance (SGLG);

WHEREAS, good governance promotes transparency and accountability in the use of public funds by delivering basic services that are responsive to people's needs and SGLG is the mechanism of the government to carry out such;

WHEREAS, the Municipal Government of Culion, recognized the need and importance to adhere to the foregoing stated order;

WHEREAS, pursuant to the above mentioned provisions, the Local Government of Culion finds it necessary to constitute its SGLG Team and its Technical Working Group (TWG) to ensure its eligibility of said seal;

NOW THEREFORE, I, MA. VIRGINIA N. DE VERA, Municipal Mayor of Culion, Palawan, by virtue of the powers vested in me by law, do hereby order:

Section 1. Composition. The Seal of Good Local Governance Team and its Technical Working Group of Culion, Palawan is hereby constituted and shall be composed of the following:


