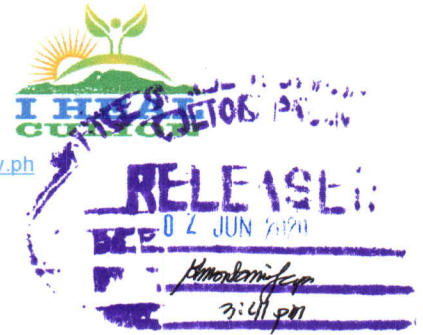

EXECUTIVE ORDER NO. 34
Series of 2020

EXECUTIVE ORDER AMMENDING “EXECUTIVE ORDER NO. 32 MANDATING THE GUIDELINES TO BE OBSERVED BY ALL RESIDENTS AND TRANSIENTS WITHIN THE TERRITORIAL JURISDICTION OF CULION WHILE THE WHOLE MUNICIPALITY IS PLACED UNDER MODIFIED GENERAL COMMUNITY QUARANTINE”

WHEREAS, IATF resolution no. 40 placed the whole Region IV-B in which the Province of Palawan forms part thereof under modified general community quarantine.

WHEREAS, the whole province is hereby classified as low to moderate risk, while our municipality remains COVID free.

WHEREAS, as we slowly transition to the new normal amidst this pandemic, certain practice must be hereby strictly be observed.

WHEREAS, since the vaccine is not yet discovered, safety precautions for prevention is the best option for all.

WHEREAS, the Modified General Community Quarantine is less stringent compared to other quarantine measures, social order must still be placed in order to ensure the safety and health of our people and ensure that our Municipality would be compliant with the National and Provincial Policies that are in effect to ensure that we remain or minimize the risk of Covid infiltration.

WHEREAS, under the Police Power of the Local Government shall promote and ensure and support, among other things, promote health and safety.

WHEREAS, the Local Government Code provides that the Municipal Mayor may issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances.

I, **MA. VIRGINIA N. DE VERA**, Mayor of the Municipality of Culion, Province of Palawan by virtue of the Power vested in me by law do hereby issue this Executive Order.

Section 1. Section 7 of Executive Order No. 32 is hereby amended to be as:

All residents who wish to travel outside Culion are hereby allowed and there shall be no need to secure any travel order from this Municipality, but all residents are reminded that they should bring a valid Government ID indicating their address here in the Municipality.

Any travel from Culion to any Municipality in the Province shall be allowed, subject to Minimum Health Standards and valid Quarantine Check Points that may be implemented. Upon their return from this Municipality from any Municipality within the Province of Palawan, a travel order shall no longer be required from them from their point of origin.

However, a valid ID shall be presented by such returnee as proof that he is a valid resident of this Municipality, it shall be required from them in order to be allowed to enter the Municipality.

For returnees from outside the Province of Palawan it shall be required that they secure a Travel Authority from their point of origin.


All incoming local residents of the Province of Palawan who would be entering the Municipality for Leisure or Business purposes are hereby required to show a Valid Government Issued ID indicating their address therein that they are legitimate Palawan residents.

Failure to present any of the requirements mandated by this executive order upon their return shall not be a ground for them to be refused entry, however they shall be mandatorily be placed under mandatory 14 days quarantine period at the Municipal Facility.

Section 2. Effectivity. This Executive order shall take effect immediately.
