EXECUTIVE ORDER NO. 39-A
Series of 2017

AN EXECUTIVE ORDER CREATING THE BUSINESS ONE STOP SHOP (BOSS) IN THE MUNICIPALITY OF CULION FOR THE SPEEDY AND EXPEDIENCY OF RENEWAL OF GOVERNMENT PERMITS TO ALL STAKE HOLDERS IN THE MUNICIPALITY

WHEREAS, under RA 9485 otherwise known as the Anti Red Tape Act, all government instrumentalities are mandated to provide efficient delivery of services to the public;

WHEREAS, national agencies which are connected to business renewals and all departments of the local government unit which are necessary for the renewal and application of business permits shall be housed under one roof to for easy and speedy process;

WHEREAS, to stimulate growth and attract potential investors by easing the doing of business in the municipality;

WHEREAS, there is a need to institutionalize the said program in order to ensure the continuous implementation of the process;

WHEREAS, the Local Government Code Provides that the Municipal Mayor may Issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances.

I, **Ma. Virginia N. De Vera**, Mayor of the Municipality of Culion, Province of Palawan by virtue of the Power vested in me by law do hereby issue this Executive Order;

Section 1. Composition the following shall form part of the Business One Stop Shop, wherein the head of each department may assign the necessary manpower to such;

- Municipal Treasury
- Municipal Tourism Office
- Municipal Agricultural Office
- Rural Health Unit/ Sanitation
- MDRMO
- Municipal Tricycle Franchising
- Philippine National Police
- Bureau of Fire Protection

- Department of Trade and Industry
- Department of Environment and Natural Resources
- Bureau of Internal Revenue
- Barangay Official Representative

Section 2. Supervision, the Municipal Administrator shall exercise supervisory power and oversee the implementation of this Executive Order, he may create a Technical Working Group (TWG) to help and facilitate the smooth operation of this program, the GSO head and Municipal Engineer shall form part of the said technical working group

Section 3. This Executive Order shall take effect immediately
