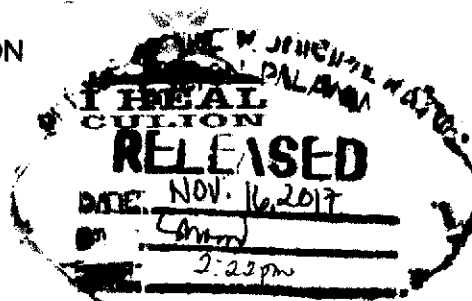

CREATING AND ORGANIZING THE CULION DRUG RELATED NUISANCE BOARD (CDRNB) IN THE MUNICIPALITY OF CULION, PROVINCE OF PALAWAN

WHEREAS, Section 52, Article VII of Act No. 9165, otherwise known as "Comprehensive Dangerous Drugs Act of 2000," and Section 447 (a) (4) (i) of Republic Act No. 7166, Local Government code of 1991 call for abatement of any declared public nuisance;

WHEREAS, the creation of a body is deemed necessary to put an end to declared drug related public nuisance which will be called "Culion Drug Related Nuisance Board" (CDRNB) with primary function of receiving and handling information and complaints of existing places or premises drug dens for pot sessions and other similar activities;

WHEREAS, all policies which are discerned significant for the furtherance of R.A. 9165 and R.A. 7160, more particularly Section 447 (a) (4) (i) thereof, must be determined and recommended by the "Culion Drug Related Nuisance Board" (CDRNB) for the ministerial approval of the Local Chief Executive;

NOW, THEREFORE, I, MA. VIRGINIA N. DE VERA, Municipal Mayor of Culion, Palawan, by virtue of the powers vested upon me by law and the sovereign will of the people do hereby order the creation and organization of the Culion Drug Related Nuisance Board in the Municipality of Culion, Palawan.

Section 1. COMPOSITION: The said Culion Drug Related Nuisance Board shall be composed of the following:

Section 2. PURPOSE- To abate activities related to the use of places or premises, buildings or structures as site for drug related public nuisances;


- b. Complainant brings before the administrative board unlawful drug related activities of parties' complained of; serve written notice of complaint to the owner of the place or structure;
- c. Within three (3) days from receipt of the complaint, a hearing shall be conducted with notice to both parties, the complainant and the respondent/owner of the place or premise, and the administrative board may consider any evidence submitted, including evidence of general reputation of the place or premises;
- d. The owner of the premises shall be given opportunity to present any evidence in his/her defense;
- e. After hearing based on the evidence presented, the administrative board may declare the subject premises to be public nuisance;
- f. If the administrative board declares a place or premises to be public nuisance, it shall issue an order immediately prohibiting the conduct, operation or maintenance of any business or activity on the premises, which is conducive to such nuisance;
- g. The hearing shall be terminated within ten (10) days from commencement.

Section 4. IMPLEMENTING ARM- The Municipal Mayor shall implement the Order of the Admin Board and shall assume full responsibility that said order is complied to the fullest;

Section 5. EXPIRATION OF ORDER- The order issued by the Admin Board and approved by the mayor shall expire in one (1) year from date of issuance thereof.

Section 6. EFFECTIVITY- This Executive Order takes effect immediately.
