**AN ORDER CREATING TASK FORCE FOR BARANGAY JARDIN
 RELOCATION PROJECT**

WHEREAS, due to the fire burning incident that happened in the evening of February 2, 2019 in the foreshore areas of Barangay Jardin, Culion, Palawan, there were several families that were affected and rendered homeless;

WHEREAS, the residence who were affected were relocated to the said area and are no longer allowed to go back to the former site that was destroyed during the fire burning incident;

WHEREAS, to immediately respond the expedient basic needs of these affected constituents, the present Municipal and Barangay Administration had established a relocation site and housing program for them at the upper area of Barangay Jardin, pursuant to the mandate of the Local Government Code;

WHEREAS, for the comfort and convenience of these relocated families, there is a need to have water, electric power facilities and a road passable going to and from the town proper to the relocation site.

NOW, THEREFORE, I, MA. VIRGINIA N. DE VERA, Municipal Mayor of Culion, Palawan, by virtue of the powers vested in me by law, do hereby order:

**SECTION 1. CREATING TASK FORCE FOR BARANGAY JARDIN
 RELOCATION PROJECT.**

SECTION 2. COMPOSITION. The Task Force shall be composed of the following:

SECTION 3. DUTIES AND RESPONSIBILITIES. The Task Force shall perform the following duties and responsibilities:


1. Coordinate with Barangay Officials of Barangay Jardin and other concerned agencies regarding proper implementation of the project;
2. Delineate right of way from the main road to the relocation site;
3. Coordinate with the Culion Water District to determine water pipe distribution lines;
4. Coordinate with BISELCO regarding electric distribution lines;
5. Ensure that there are sanitary toilet facilities in every house hold.
6. Recommend such other measures necessary for the proper and effective implementation of the project.

SECTION 4. REPEALING CLAUSE. This Executive Order shall supersede all previous Executive Order issued to this effect.

SECTION 5. EFFECTIVITY. This order shall take effect immediately.
