



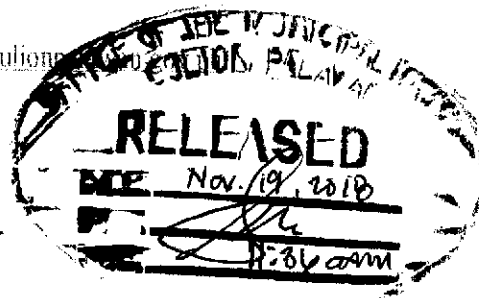

EXECUTIVE ORDER NO. 54
 Series of 2018

CREATING THE MUNICIPAL TOURISM PLANNING COMMITTEE PRESCRIBING ITS COMPOSITION AND RESPONSIBILITIES AND PROVIDING FUNDS FOR ITS OPERATIONS THEREOF

WHEREAS, local government units are mandated to develop and promote the general welfare of the people and thereafter potential economic sectors like tourism;

WHEREAS, DILG Memorandum Circular No. 95-162 encourages local chief executives to organize tourism councils and planning committees composed of government and private sector representatives for the formulation of programs in developing tourism facilities and attractions through tapping local resources and funding;

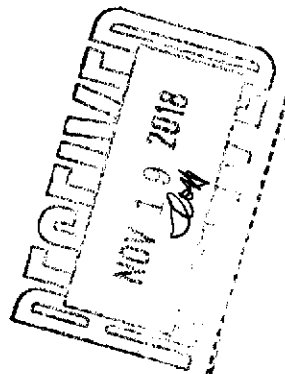
NOW, THEREFORE, I, MA. VIRGINIA N. DE VERA, Municipal Mayor of Culion, by powers vested in me by law, do hereby order the creation of the Municipal Tourism Planning Committee to primarily spearhead in the formulation of the Municipal Tourism Development Plan.

Section 1. Composition.

Section 2. Functions and Responsibilities

- a. Prepare the Municipal Tourism Development Plan (2019-2023) as the benchmark and update the Plan every two (2) years thereafter;
- b. Generate and validate information and data necessary to firm-up programs and projects of the Municipal Tourism Development Plan;

- c. Coordinate with external agencies, local and foreign institutions for possible funding support of programs and projects identified under the Plan;
- d. Monitor the implementation of programs and projects on a regular basis; and
- e. Perform other tasks as may be deemed necessary in attaining tourism development goals in Culion.

Section 3. General Roles of the Committee

The Chairperson shall preside over all planning sessions and may designate his alternate during his absence. Further, the Chairperson shall be responsible in directing and overseeing the timely completion of the Municipal Tourism Development Plan.

The Committee members shall actively participate in the drafting of the Municipal Tourism Development Plan which must incorporate realistic goals, appropriate strategies and programs and projects which best contribute to the attainment of tourism goals and objectives.

Funding

The operational expenses of the Municipal Tourism Planning Committee shall be charged against the general fund of the Office of the Municipal Tourism Officer.


Repealing Clause
