WHEREAS, the appropriation for donation and other maintenance & operating expense in the budget of the office of the municipal OSCA for budget year 2019 needs to be augmented again;

WHEREAS, the appropriations for the following expense items of the office aforementioned for the same budget year are no longer needed by said office thus are considered savings: capital outlay in the amount of PhP 15,107.00 and other general services expense in the amount of PhP 50,000.00;

WHEREAS, Section 336 of Republic Act No. 7160 or the Local Government Code of 1991 provides that the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;
