

Section 1. Creation of Plantilla Positions. It is hereby created the following plantilla positions in the municipal government of Culion, Palawan, to wit: a) BOOKBINDER I-S.G. 2, BOOKBINDER III-S.G. 7, LOCAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER I-S.G. 11 IN THE OFFICE OF THE MAYOR; b) TWO(2) BOOKBINDER I-S.G. 2, TWO(2) ADMINISTRATIVE AIDE II-S.G. 2 IN THE OFFICE OF THE MUNICIPAL ADMINISTRATOR; c) PLANNING OFFICER III-S.G. 18, PROJECT DEVELOPMENT OFFICER II-S.G. 15 IN THE OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT; d) CONSTRUCTION AND MAINTENANCE FOREMAN-S.G. 8 IN THE OFFICE OF THE GENERAL SERVICES; e) BOOKBINDER IV-S.G. 10 IN THE OFFICE OF THE MUNICIPAL ACCOUNTANT; f) TAX MAPPING AIDE-S.G. 4 IN THE OFFICE OF THE MUNICIPAL ASSESSOR; g) AQUACULTURIST II-S.G. 15 IN THE OFFICE OF THE MUNICIPAL AGRICULTURIST; h) CONSTRUCTION & MAINTENANCE GENERAL FOREMAN-S.G. 11, ADMINISTRATIVE AIDE II-S.G. 2; i) TWO(2) SOCIAL WELFARE AIDE-S.G. 4 IN THE OFFICE OF THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT; AND j) SANITATION INSPECTOR III-S.G. 11 IN THE OFFICE OF THE MUNICIPAL HEALTH OFFICER.

Section 2. Personal Services Requirement. The PS requirement of each of the plantilla positions herein created shall be charged against the appropriation for the position as provided in the annual expenditure program of the municipality for FY 2020 subject however to the PS limitation as provided for under the Local Government Code of 1991 and that adequate appropriation for the personal services requirement of the same be provided also in the annual budget of the municipality in every fiscal year thereafter.

Section 3. Separability Clause. If, for any reason, any section or provision of this Ordinance is disallowed or declared invalid by proper authorities, other sections or provisions thereof that are not affected thereby shall continue to be in full force and effect.


Section 4. Repealing Clause. Any local legislative measures previously passed or parts thereof, which are inconsistent or in conflict with the provisions of this ordinance are hereby repealed and/or modified accordingly.


Section 5. Effectivity. This ordinance shall take effect upon its approval.


