ORDINANCE AUTHORIZING THE AUGMENTATION OF THE HEREIN-MENTIONED FUND ALLOCATION IN THE BUDGET OF THE OFFICE OF PERSONS WITH DISABILITY(PWDs) AFFAIRS FOR FY 2019 BY SAVINGS FROM BUDGET OF SAME OFFICE FOR THE EVEN FISCAL YEAR

WHEREAS, the allocation for christmas celebration and gift-giving in the budget of the Office of the PWD Affairs for budget year 2019 needs to be augmented;

WHEREAS, the appropriations for the following expense items of the office aforementioned for the same budget year are no longer needed by said office thus are considered savings: traveling expense in the amount of PhP 17,587.54; document services/printing in the amount of PhP 3,243.00; refreshments for quarterly and special meetings in the amount of PhP 7,445.00; honorarium of PWD federation president in the amount of PhP 12,000.00; honorarium of 13 PWD chapter presidents in the amount of PhP 44,000.00; paralympics and national celebration in the amount of PhP 25,000.00; other MOOE in the amount of PhP 17,000.00;

WHEREAS, Section 336 of Republic Act No. 7160 or the Local Government Code of 1991 provides that the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;

NOW, THEREFORE, premises considered, be it enacted by the 9th Sangguniang Bayan of Culion, Palawan by virtue of the powers vested in it by law in session duly assembled, THAT:


Section 1. AUTHORIZATION TO AUGMENT. The following fund augmentations in the office of the municipal PWD affairs of Culion, Palawan for budget year 2019 are hereby authorized, to wit:


