RESOLUTION AMENDING IN PART RESOLUTION NO. 2019-1584 ENTITLED "RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR OF CULION, PALAWAN TO ENTER INTO AND SIGN THE WATER LEASE CONTRACT WITH THE AYIN ZAYIN CORPORATION COVERING THE PORTION OF MUNICIPAL WATERS BETWEEN BUGOR ISLAND AND SAND ISLAND IN BARANGAY LIBIS, CULION, PALAWAN" FOR THE PURPOSE OF REDUCING THE AREA OF THE MARINE WATERS TO BE LEASED FROM 14.9514 HECTARES TO 10.0346 HECTARES SINCE THE 4.9168 HECTARES FALL ON NON-ALLOWABLE AREA BASED ON THE APPROVED ECAN ZONES MAP OF THIS MUNICIPALITY

WHEREAS, in its 24th regular session held on December 16, 2019, the 9th Sangguniang Bayan of Culion, Palawan adopted Resolution No. 2019-1584 authorizing the municipal mayor of Culion, Palawan to enter into and sign the water lease contract with the Ayin Zayin Corporation covering the portion of municipal waters between Bugor Island and Sand Island in barangay Libis, Culion, Palawan";

WHEREAS, the number of hectares of marine waters to be leased by the Ayin Zayin Corporation stated in the aforesaid resolution is 15 hectares or 14.9514 to be exact;

WHEREAS, based on the approved ECAN zones map of this municipality, the 4.9168 hectares out of the 14.9514 hectares aforementioned fall on non-allowable area;

WHEREAS, there is thus the imperative need to amend in part Resolution No. 2019-1584 in order to reduce the 14.9514 hectares to 10.0346 hectares;


Premises in view, be it, THEREFORE, RESOLVED by the 9th Sangguniang Bayan of Culion, Palawan to amend in part Resolution No. 2019-1584 entitled "Resolution authorizing the municipal mayor of Culion, Palawan to enter into and sign the water lease contract with the Ayin Zayin Corporation covering the portion of municipal waters between Bugor Island and Sand Island in barangay Libis, Culion, Palawan" thereby reducing the area of the marine waters to be leased from 14.9514 hectares to 10.0346 hectares since the 4.9168 hectares fall on non-allowable area based on the approved ECAN zones map of this municipality;

RESOLVED FURTHER, that all offices and entities concerned be furnished with copies of this resolution by the office of the mayor for their information and reference;




