RESOLUTION ENDORSING THE IRIS ISLAND ECO RESORT AND NATURAL SPA, A BATHING ESTABLISHMENT PROJECT LOCATED AT DARAB ISLAND IN BARANGAY LUAC, CULION, PALAWAN PROPOSED BY NAVRATIL ISLAND PROPERTY CORPORATION RELATIVE TO ITS APPLICATION FOR FOREST LAND AGREEMENT FOR TOURISM(FLAG-T), ENVIRONMENTAL COMPLIANCE CERTIFICATE(ECC), AND SEP CLEARANCE

WHEREAS, Navratil Island Property Corporation represented by its president, Dr. Frank Navratil plans to undertake a bathing establishment project, i.e. Iris Island Eco Resort and Natural Spa at Darab Island in Barangay Luac, Culion, Palawan and is applying for Flag T, ECC, and SEP clearance from the concerned agencies of the government;

WHEREAS, the proposed project is an environmentally acceptable undertaking and has positive impact upon the efforts of the local government to promote ecological and self-sustainable tourism in Culion;

WHEREAS, the project when implemented will provide employment opportunities and trade even for local individuals and businesses as well as generate revenues for the municipal government of Culion;

WHEREAS, the proposed project has already been endorsed by the barangay government of Luac;

NOW, THEREFORE, in consideration of the foregoing premises, be it **RESOLVED** by the 9th **Sangguniang Bayan of Culion, Palawan** to endorse the Iris Island Eco Resort and Natural Spa, a bathing establishment project located at Darab Island in barangay Luac, Culion, Palawan proposed by Navratil Island Property Corporation relative to its application for forest land agreement for tourism, environmental compliance certificate, and SEP clearance;

RESOLVED, that the Navratil Island Property Corporation shall comply with all existing national and local laws, policies, rules and regulations pertinent to operation of the resort especially with the Ecological Solid Waste Management Act in so far as waste management and disposal are concerned;


RESOLVED, that this resolution shall not be utilized as basis or in support of any claims for private ownership of Darab Island since this is not contemplated in this resolution whose sole intent is simply to endorse the hereinmentioned project in view of the perceived benefits to local economy, employment, environment, tourism, and revenue-generation derived therefrom;

RESOLVED FINALLY, that all offices and entities concerned be furnished with copies of this resolution by the office of the mayor for their information, reference, and/or guidance;


