RESOLUTION REQUESTING THE PROVINCIAL GOVERNMENT OF PALAWAN IN CONJUNCTION WITH THE DEPARTMENT OF EDUCATION(DEPED)-PALAWAN TO ENCOURAGE STUDENTS OF BOTH PUBLIC AND PRIVATE SCHOOLS IN THE PROVINCE OF PALAWAN TO WATCH THE MOVIE "CULION" FOR THEM TO GAIN KNOWLEDGE ABOUT PART OF THE HISTORY OF CULION AS A FORMER LEPER COLONY WHICH IS NOW ONE OF THE MUNICIPALITIES IN THE SAID PROVINCE

WHEREAS, in July of last year, the movie entitled "Culion" was filmed in its entirety in the municipality of Culion, Palawan under the auspices of "iOptions Ventures Corporation" that became an entry to the 2019 Metro Manila Film Festival;

WHEREAS, in that movie which is graded A by the Cinema Evaluation Board, a part of the history of Culion as a former leper colony is vividly shown notably the way of life of the hansenites in the midst of stigma and isolation during the pre-war period, the government regulations on them, the manner how they were cared and treated by the government, the rights which the patients then were deprived of, the excruciating loneliness and despair they had experienced, and the hope of healing and later on political empowerment that would bring them back to the mainstream society, raise families of their own self-reliantly and free from any restrictions, and live normal lives again as gregarious human beings;

WHEREAS, it is but of paramount importance not only for the present generation of Culion people especially the youth but for the Palawean students as well to know and understand the rich and unique history of Culion as a leper colony where the municipality has evolved from for this will enable one to better appreciate what Culion was yesterday thus valuing heritage and what it is today thereby contributing significantly in the effort of promoting historical tourism therein;

WHEREAS, knowledge and understanding of such history can be acquired by watching the movie "Culion";

WHEREAS, this August Body is of the belief that the provincial government and the DepEd-Palawan are a strong force to reckon with in order to persuade or encourage students in the province of Palawan to see the movie "Culion", hence, the purport of this resolution;




