**WHEREAS**, Section 443(d) of the Local Government Code of 1991 explicitly provides that heads of municipal departments and offices shall be appointed by the municipal mayor with the concurrence of the majority of all the sangguniang bayan members subject to civil service law, rules and regulations (underscoring supplied);

**WHEREAS**, results of the votes clearly show that the legislative concurrence with the subject appointment has met the required number of affirmative votes as set by law;

**WHEREFORE**, premises considered, be it **RESOLVED** by the 9<sup>th</sup> Sangguniang Bayan of Cullion, Palawan to concur with the appointment of Philbert Mark B. Isabelo to the position of Municipal Department Head I (General Services Officer I) of Cullion, Palawan issued on February 3, 2020;
