WHEREAS, the Local Government Code of 1991 mandates each local government unit to have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian;

WHEREAS, the CDP of Culion embodies a six(6)-year plan of actions based on the ecological profile of the major sectors of economic, social, infrastructure, environment and natural resources and institutional development;

WHEREAS, the Local Development Investment Program, on the other hand, serves as the implementing instrument of the CDP which articulates the financial requirements of programs, projects and activities identified in the Plan including their timeframe and responsible departments for the first 3 years of the CDP, that is from 2021 to 2023 while the annual investment plan operationalizes the annual budget of the municipality;

WHEREAS, the provincial government of Palawan has directed all LGUs of the province to ensure timely compliance of the CDP and alignment of the PPAs with the thrusts of the province and those of the national government;






